Following your request during the May 2023 Hearing sessions the Council sent a copy of an updated Housing Trajectory to Mark Behrendt of the Homes Builders Federation on 12 November 2024. At the hearings he agreed to disseminate information to others involved in the Local Plan Examination to work towards a Statement of Common ground with the Council. Officers met with Mr Behrendt and others on 9 December to update them on the Local Plan and draw their attention to Cllr Beecher's letters to the Inspector, the newly published Local Development Scheme and hear their initial thoughts on the Housing Trajectory update. Officers assured those attending that they would be kept updated as soon as information was sent to you and published on the website.

Spelthorne Council fully recognises that modification of the Local Plan at this stage rests with yourself as Inspector and that we are simply requesting that you give consideration to the modifications proposed. We would be happy to provide you with any further information or evidence to enable you to decide whether these modifications can be accepted and discussed further through the hearing sessions once the examination resumes.

We would be grateful if you could let me know how you would like to take things forward at your earliest convenience. We wish to offer our continued assurance that Spelthorne wishes to have a Local Plan in place at the earliest opportunity and very much hope you will agree to resume the examination hearings shortly.
